\_\_\_ **Regular Member**-Initiation \$1,000 with application. Monthly Dues of \$325.00 ; food and beverage minimum of \$80.00 per month; includes use of the pool.

\_\_\_ **Junior Member**-Initiation \$500. Dues vary by age until 40<sup>th</sup> birthday; food and beverage minimum of \$65.00 per month; includes use of the pool.

\_\_\_ **Corporate Membership**. This membership is designed for multiple memberships from one business or corporation.

\_\_\_ **Non-Resident Membership**. Must reside more than 60 air miles from VCC for 8 months. (Includes golfing, dining and option for pool use).

\_\_\_ **Social Membership**-Initiation \$100. Dues are \$35 per month; food and beverage of \$65 per month. Includes option for the pool and limited golf.

**2012 MEMBERSHIP DETAILS**

**Regular Membership-Voting Membership.** Pay \$1,000.00 Initiation Fee with application. Dues will be \$225.00 per month for balance of 2012. Full dues of \$325.00 will begin Jan. 2013. \$80 per month dining minimum to apply. Range fee, Bag storage and locker fee will be billed. Enjoys all privileges of VCC, *including the pool.*

**Junior Membership-For applicants 21-40 years of age.** Pay Initiation Fee of \$500 with application. Range, bag storage and locker fees billed will be billed. \$65 per month dining minimum to apply. Enjoys all privileges of VCC, *including the pool.* Monthly dues will be:

Age 21 to 24	\$125.00
25 to 29	\$150.00
30 to 34	\$175.00
35 to 39	\$225.00

Becomes a Regular Member on 40<sup>th</sup> Birthday month, no additional fee.

**Corporate Membership – One Initiation fee of \$1,000.** Allows up to 5 golfing members (Regular or Junior) from same corporation. Prevailing dues and dining minimums for each member. Annual fees for Range, Bag storage and locker apply. Enjoys all privileges of VCC. Members may be replaced at no charge.

**Non-Resident Membership – Must reside at least 60 miles from VCC for at least 8 months of the year.** Annual fees for one golfer are \$600. Annual dining minimum is \$300 each calendar year. Allows for 10 rounds of golf with the option to buy additional 10 rounds at guest rates. If spouse is included, annual fee is \$900; dining minimum is the same \$300.00. Allow for same amount of golf with the option to purchase at guest rates. *Pool is available at the prevailing rate for the season.*

**Social Membership – Initiation fee is \$100.** Monthly dues are \$35 per month with the monthly dining minimum of \$65. *Pool privileges available at prevailing rate.* One round of golf during the months of June, July and August. and up to two rounds of golf per month during the off season – these are at prevailing guest rates.

**Dining Membership- No Initiation fee, monthly dues or dining minimum.** *No golf or pool privileges available.* Pay \$250 when join which applicable towards food and beverage. If the \$250 is used, dining may continue using a credit card or direct billing. The \$250 must be used in the calendar year 2011.

**Preview Golf Membership – No initiation fee, monthly dues or dining minimums.** Purchase a “Book of Tickets” for \$1000. This will contain 20 rounds of golf at VCC including a cart. Must be used in calendar year 2012. Not all dates or times will be available. Participation in tournaments not permitted. Limited number of “Books” available. *No pool privileges available.* Food and beverages will be available for purchase with credit card.

*Pool Season privileges include the member, spouse, children under the age of 21 living in the parent’s house. All guest of all ages pay guest fees when accompanied by a member.*
